## Sub: Grant of honorarium/remuneration to the officers/scientists of the Institutes for conducting training classes and for delivering lectures to the trainees.

Sir,

I am to invite a reference to the Council's circular No. 15(12)/71-Cdn.II dated 10.3.1973 (Copy enclosed) emphasizing there in that no honorarium/remuneration to the officers/Scientists of ICAR Institutes for conducting the training classes and for delivering lectures to the trainees should be granted except for courses sponsored by International Agencies. It has, however, been observed that the above instructions are not being strictly followed by some Institutes of the Council. The Director of Audit has also raised audit objection on this account while auditing the accounts of a number of Institutes.

2. Since the payment of honorarium to the Scientists for delivering lectures in Seminar/Symposia/Workshop/Internal courses financed by the Council and other National Organizations has been adversely commented upon by the Director of Audit with the observation that the amount already paid to the Scientists should be recovered from them, it is retreated that the instructions contained in Council's circular referred to above should be scrupulously followed.



I am directed to refer to this Council's letter of even number dated the 17<sup>th</sup> August, 1971 on the above noted subject and to say that the question of the grant of honorarium/remuneration to the officers/scientists of the ICAR Institutes for conducting the training classes and for delivering lectures to the trainees was considered by the Internal Policy Committee of the Council at its meeting held on the 18<sup>th</sup> July, 1973. The Committee decided that no. Honorarium except in courses sponsored by International agencies should be paid to the employees of the ICAR or lectures given during internal courses financed by the Council and other national organizations and that the funds set aside for this purpose will be utilized by the Institutes for improvement of the courses and for developing library and audiovisual facilities. This decision, however, will not be applicable to the visiting and guest lecturers.

It is requested the above decision may kindly be noted for compliance.

#### **OFFICE ORDER**

In continuation of the Council's Office Order No. 11(1)/79-CDN.II dated 26<sup>th</sup> March, 1981, It has been decided to enhance the rate of honorarium from Rs. 100/- to Rs. 200/-(Rupees two hundred only) per day to the Chairman and members i.e. the non-official members of the Qinquennial Review Team (Q.R.T),. Appointed by the ICAR, with the following terms and conditions:-

- (i) Each non-official (Scientist, Technicians, Academician and others) employed on conducting the Quinquannial Review Team of ICAR Research Institutes, Coordinated Research Projects, Research Centers and other Research Schemes will be paid honorarium Rs. 200/- par day for every day they spend on this work subject to the limit of Rs. 7,500/- per Scientist over a period of 6 months. This honorarium will be in addition to the normal TA/DA as admissible under the existing rules of ICAR. Retired persons appointed as members of the Q.R.T. will also be treated as non-officials.
- (ii) The honorarium will be payable for the number of days (not less than six hours) actually spent at the Institute or the headquarters or any other Centers of the Project/Scheme for evaluation and assessment of the working of the Institute/Scheme. This will not include the time taken, in travel from his normal place of duty/residence to the place of assignment and back or the period of enforced halts.
- (iii) For purposes of calculating the honorarium, any holiday in between the duration of the days as indicated at (ii) above will be considered as "on duty" and per diem will be payable.
- (iv) The members will have to devote their full time for the work and may take permission from their employer for the related period. They will complete the work as assigned to them within the period specified for the purpose.
- (v) The employees of the ICAR when associated with the Quinquennial Review Teams will not be paid any honorarium. Similarity, the employees of the State Governments or Universities, when appointed to assist in the evaluation of a Research Scheme/Project in their own State/University will not be paid any honorarium but when they are appointed to assist in the evaluation of the Research Scheme/Project in States/Universities other than their own, they will be paid the same honorarium as paid to other non-officials, in accordance with this order.

- (vi) These orders will not be applicable to non-officials and others for attending the meeting of Standing Finance Committee/Governing Body/Scientific Panel or any other body.
- (vii) These orders will be effective from the 27<sup>th</sup> April 1988.

2. The expenditure on the payment of honorarium and TA/DA of the non-official members of the Q.R.T. will be met by the concerned Institute/Directorate/Project/Center for which necessary budget provision will be made under "Other Charges" and not under "T.A." which is meant for the staff of the Institute/Directorate/Project/Center.

3. This issues with the concurrence of the Ministry of finance, Department of Expenditure, vide their U.O. 714/E.II\_3168 dated the 27<sup>th</sup> April 1988.
