The firm should be the original manufacturer having ISO Certification / Foreign Principal of said items or the authorized Indian stockist of foreign/Indian manufacturers having custom based warehouse in India, if any, as the IIRR is exempted from the payment of Custom/Excise duty, for the purpose of purchase of these items. The firms applying for contract must attach their latest price list, catalogue, Client List and should clearly mention the percentage of discount they wish to offer on their products along with a certificate that the discount offered is the maximum which is being given by the company to any organization whether Government or Private (In the enclosed pro-forma). The applications along with a **non-refundable fee of Rs.2,000/- (Rupees Two Thousand only)** must reach the Senior Administrative Officer, IIRR, Hyderabad, latest by **23-08-2021**. The Competent Authority has full right to accept or reject any Rate Contract proposal, without assigning any reason.

**TERMS & CONDITIONS FOR RATE CONTRACT**

1. No equipment, apparatus, Gel electrophoresis apparatus and Analytical services etc. shall be covered under the rate Contract.
2. The packing, freight, forwarding, insurance charges, if any, will not be borne by the purchaser. Similarly any loss, damage, pilferage etc. of the material on transit will have to be borne by supplier as it shall be the sole responsibility of the supplier. The defective supply, if any, is to be replaced by the supplier within 7 days bearing freight/transport charges.
3. The delivery /supply should be by the supplier made on F.O.R. basis to the Indian Institute of Rice research Rajendranagar, Hyderabad-30
4. Sales Tax/VAT, Excise Duty and other Govt. levies will be paid extra as applicable under rules.
5. The supply of material will have to be completed within 30 days from the date of Issuing purchase order. In case of delay or non-compliance of this order liquidated damages will be levied @ 2% per week subject to maximum of 10% of the order value. After lapse of 10 week's orders shall stand cancelled automatically, if supply is not effected within 10 weeks.
6. No payment will be made in advance even through Bank. But the payment will be released within 30 days through the mode of E-payment only after receiving goods in full to our satisfaction. Pre-receipted bills (in triplicate) affixing revenue stamp, should be sent to the Director, ICAR-IIRR, Hyderabad. No interest will however, be payable in case of delayed payments.
7. Payment will be made according to the current price-list as accepted by the IIRR under rate contract and no price revision in rate (on higher side) will be accepted during the period of rate contract.
8. The order will be placed as per requirement irrespective of value of the order.
9. Any dispute arising between the manufacturer and the purchaser will be referred to institute for which sole arbitration and decision thereof shall be final and binding upon the parties i.e. manufacturer/supplier and purchaser.
10. Supply should be made in full against the order and no part supply will be accepted.
11. No payment will be made for unsatisfactory supply made which is not to institutes satisfaction.
12. The articles should be securely packed to avoid damages etc., during transit.
13. Supply to be made from the latest batch of production with maximum life period in original packing.
14. In case the proposal is accepted, the firm shall sign an agreement with us before entering into rate contract.
15. The Director, IIRR reserves the right to cancel the rate contract at any time without assigning any reason thereof.
16. The rate contract will be valid for a period up to 31.03.2022 from the date of award of the Rate Contract.

17. A certificate is to be given by the firm that the price list supplied is the only one in circulation (In the enclosed proforma).
18. Price list duly signed & certified by the authorized signatory which, should be current only should be provided.
19. Discount, if any on the ruling prices may be mentioned clearly with trade discount certifying that higher discount is not given to any other Department.
20. All questions, disputes or differences under, out or in connection with the contract, if concluded shall be subject to the jurisdiction of the court within the local limits of Hyderabad.
21. In case of discrepancy between unit prices and total price, the unit price shall prevail.
22. In case of supply of goods made through dealer, their name and mail address may be declared / indicated.
23. The dealers/Stockist/Distributors should submit a copy of Authorization letter from the Original Manufacturer/Principal company.
24. Wherever applicable, minimum warranty should be one year.
